Introduction to the University

#### The Thought of Establishing of the University

The idea of establishing the university dates back to 1993, when a group of professors from the National University of Somalia, others from international universities, and some prominent figures in the society sat together. The primary motivation behind the idea of establishing a none state university in the country, despite the difficult circumstances of the civil war, was to break the chains of despair and frustration and help students who had completed secondary studies and were unable to continue their education because of the civil war.

After intensive discussions in 1994, the participants reached the need to form a committee to study the subject and how to achieve this ambitious project.

On August 9, 1996, the committee presented its vision on the project, and it was discussed, and the participants decided to start implementing the plan and take all requirements from the preparation of the curricula, regulations and governing system of the university functions.

On September 22, 1997, Mogadishu University was opened officially, and embarked on the study of five significant faculties which are:

This opening was a significant event in Mogadishu, which raised a great debate about the possibility of opening a university in the difficult circumstances that the country was going through. But, the young people were thrilled by this historical event, which opened a future door for an academic opportunity that offers them and their community the science and knowledge to help them out of ignorance dominates their lives.

Since that time, Mogadishu University has become a guiding light in the field of higher education in Somalia. It has created hope among our people who lived the worst life in their contemporary history. MU was the first university that has made Arabic and English language as official languages in Somalia.

#### University Location

The main campus of the university is located in Mogadishu, the capital city of Somalia.



#### Required Admission Documents:

- 1. Original secondary school certificate and one copy.
- 2. Birth certificate
- 3. Certificate of good conduct
- 4. Four colour photos (6x4) cm.
- 5. Completed application form
- 6. Receipt of Payment of the non-refundable registration fees.
- 7. File to keep documents

8. The student must be mentally fit and healthy free from any disability that hinders the progress of the study

9. The student must pass the written and oral admission exam.

10. The student will be admitted to the university after completing the registration procedures, receiving the university ID card and paying the first installment of the tuition fees.

After the admission of the student, he/she shall receive a student ID card from the university. This ID will be used to enter the MU campus, classes and library. Students should show it when requested, and this ID is the property of the university. The Admission and Enrollment Office is the last place where the student obtains his/her graduation documents.

In addition to the admission process at the university, the admission and registration department carries out a set of necessary skills that contribute to the progress of the educational process, which includes:

1. Arranging the schedule of materials for each semester in cooperation with the dean of the faculties.

2. Arranging and finalizing the final exam program.

3. Documenting and record-keeping student grades accurately in more than one format.

4. Follow up transactions at the various students such as withdrawal and transfer from one faculty to another.

5. Providing the student with various documents, such as grades, student proof, etc., what the student needs

6. Providing all departments of the university such as information, reports and tables related to students and subjects

7. Providing student graduation documents and their grades in Arabic and English



# Student Affairs

#### Student Affairs Deanship

The following considerations shall be taken into account in the distribution of students to the university's faculties and departments:

- 1. The student's desire for the required specialization.
- 2. The final result of the admission test and personal interview;
- 3. The average grade of the secondary school certificate
- 4. Vacancy seat in the field of specialization

Students Affairs Deanship established with the university on 1997, and it is concerned with creating conducive university environment and provide the reasons for students' stability in order to achieve optimal growth and integration desired in the personality of the university' student, strengthening bonds of association and cooperation between students, and providing comprehensive service to students during their study in the university and after graduating.

The deanship of student affairs takes over great importance of social and psychological distances to help the students to adapt and integrate into university life and overcome the problems they face inside and outside the university, as it also concerned with building a culture of volunteering and public service among students.

Sports and cultural activity is a great significance in the agenda of the office, and it works hard to provide the various services and events of the students.

Additionally, the office aims to reveal and uncover the talents of the students and their creativity to improve their work skills and guide them. Besides, the office pays special attention to issues of honouring students who are creative and superior in the aspects of various activities and creations. Through the Mogadishu university alumni club, the office prepares the graduates. It qualifies them with the skills that help them to obtain employment opportunities that suit their specialties and trends through holding courses on the skills required to enter the labour market and develop a culture of appreciation of work, and provides job opportunities for university graduates.

# Services offered by the Students Affairs Deanship:

#### First: services for Students before joining the university

It is one of the services that are offered to students at this stage to introduce the faculty or university, and the available specializations and study system, Also, what services and activities the institution of higher education can provide, so that the student can determine the future use of that responsibility to make the appropriate decision and plan it.

#### Ŗ Ways to provide this service:

• Faculty or university officials visit secondary schools and give informative lectures to last year's advanced level students.

• Distribution of university brochures that explains different academic aspects and another university/faculty activities and services.

• Inviting secondary graduate students from high schools to visit faculties or university in form of small or large groups depending on the circumstances and possibilities at certain times and then arrange a specific program that these visitors can be introduced many aspects of university life, its activities, programs and services, and also to introduce them to some university figures to help benefit from them through dialogue, consultation, guidance and direction.

# Second: The services offered by the student affairs department from application to graduation:

- Welcoming new students.
- Student's Guidance and Counselling Service.
- Consultancy service
- disciplining
- Issuing university's card
- Organizing various student activities
- Organizing scholarships and exemptions
- Honoring distinguished and outstanding students.
- Issuing a certificate of ethical conduct and behavior to those who request.
- Receiving and delivering of the lost belongings to their owners.

#### **Third: Services after University Graduation**

This service aims at following up the link between the university and the faculty and its graduates, to achieve scientific, educational and professional benefits;
Taking advantage of old graduates what is new in their fields of specialization and knowledge.

• Sending all university publications to the graduates, especially his/ her area of specialization and interests.

• Inviting graduates to attend some occasions such as graduation ceremonies or acquaintances and other events.

#### University student ID card:

After completion of the registration and acceptance process and paying the required fees, the student shall receive a university student ID card. This ID is the property of the university. It should not be used by anyone else, and every student has the right to carry his card in the campus and during the examinations. Students should show it when requested by the university staff who has the authority to do so.



#### Scholarships and tuition fee exemptions

Considering the financial difficulties, University reduces the financial burdens put on parents. It offers a variety of scholarship opportunities for students, across various routes and it's carried out in the following areas: 1) Scholarships for the top students graduating from the secondary schools. This scholarship is offered by the University to the educational non-state umbrellas such as FPENS, SAFE and many others. These scholarships cover all graduated students from secondary schools throughout Somalia, provided that be a top student. 2) Scholarships are offered to the families who are financially strained to pay for more than one student. The concept is based to encourage such families and to provide scholarship that is equal to 33% of fees for any two or more students from the same family.

3) Annual scholarship is offered to the students who score the highest grades of his/her department. This annual scholarship is aimed to encourage competitions among students.

4) A special annual scholarship is offered for the students who memorize the Qur'an.
5) If a university employee spends at least five years in the University, he/she is privileged to two exempted positions to his/her offspring each time they enrol at the University. There are other opportunities for scholarships to be awarded by individuals and institutions at home and abroad during the course of the studying.
6) The University lobbies for postgraduate scholarships offered for the outstanding students who graduate from the University. This scholarship is received through collaborative agreements with other universities and aims to train the teaching staff of the University.

The scholarships offered by the University to its students, regardless of their background, undergo accurate scales and standards based on the level of scientific and moral for students and their participation in various student activities.

#### Various student activities

Deanship of student affairs usually prepares various programs and activities that help to invest students' time which returns benefit and interest to them and provide them with many opportunities for developing and refining their talents and satisfying their hobbies in various areas of activities. And also to provide all services that help students to keep their good and energy continue in their studies without any constraints. It is not only a matter of opening up the school year.

But also extends to the summer vacation in the belief that the University will continue its mission towards its students, because university educational stage imprints a strong and profound impact on the student's personality, the University adopted in the preparation of its student a plan on the scientific basis in the quality of programs in order to achieve the objectives for the widest range and the most comprehensive benefit.

The student activities which the Student Affairs Deanship gives attention emphasize in the following areas:

#### **Orientation Week for New Students**

The University seeks to assist students in achieving their education goals by providing them with all the necessary services available.

During the orientation week, students are welcomed and guided until they can make the right decisions in determining their study preferences.

# 🕒 Tuition Fee:

1. Student fees must be paid immediately after he or she enters the class.

2. The student fees are paid based on the Semester or course.

3. Students should also pay other fees other than tuition fees, such as enrolment,

exams, graduation, among others., as determined by the University's administration.

4. University's administration may impose other fees on students other than the study fees.

#### 💼 A. Payment method

1. Student fees are deposited in the University accounts at the following banks: Dahabshill Bank, Premier Bank, IBS Bank, and Salama Bank. The payments are paid in a lump sum or two installments for each Semester.

3. Registration fee is non-refundable in nature and does not account for tuition fees 4. It is not permissible to transfer the student's tuition fees to another for any reason. 5. Every student who has received a full scholarship will pay administrative costs determined by the University.

6. Students are allowed to stop the study before the start of the final exam in the Semester and pays administrative costs, where they do not pay tuition fees. 7. A student is allowed to stop the study before the start of the final exam in the administrative Semester They and pays costs. do not charge tuition fees. 8. Α Student is not allowed to take advantage of two grants at once. Students examination 9. should pay the fees in each Semester. 10. The student withdrawing from the study before the commencement of the final administrative 25% tuition examination will costs of the fee. pay of

#### The rights of the student during the study

 A student has the right to ask for a review of his or her final exam-score within two weeks from the date of releasing the results, And the Dean or his representative form a committee to confirm whatever errors committed and to re-marking the subject where deemed necessary.
 The University seeks to ensure that all its students have the right to compete fairly with their peers while fighting against fraud in exams. If caught in cheating, whatever its level, obliges the concerned authority to take the necessary measures to protect students' rights.
 All students shall be equal to rights and duties, including scholarships provided by the University to its students, following general standards as determined by the university regulations.

4) Whatever the background, the University shall protect the identity of the student from any abuse or humiliation to his dignity.

# **Offences and Disciplinary Procedures for Students**

Offenses	Penalties
1. disrupting the order in the lecture hall	Take the student out of the lecture room and call the guard if it needs to get him out of the hall.
2. Disturbing the order and the discipline which the lectures and exams in the university require	Disallowing the student from attending some of the lectures that he/she has disturbed the order or denying him all the lectures of the concerned course.
3. Systematic abstaining from attending lectures and other university's activities that the regulations oblige attendance	Three levels of warning (first, second, and third)
4. Possession of firearms inside the University campus	Alert - then Warning.
5. Forming associations within the university or participation without previous license from the competent authorities.	Barring the student from practicing activity or more student activities to specific period
6. Distributing of papers, issuing of newspapers or collecting signatures or donations without obtaining a permit from the competent authorities or abuse of the permit granted for the exercise of the activities mentioned	Warning for its three scales (First, second, and third).
7. Use of the university buildings, facilities, annexes and houses prepared for students and clubs for purposes other than those prepared for them.	Depriving benefit from the services provided by the facility or more facilities of the university (in which the offense was committed)
8. Destruction of any of the University's movable and non-movable property intentionally	The student shall be fined at least twice the current price of thing or things which is intentionally damaged.
9. Any insult or abuse directed by the student to a member of the faculty or any of the employees or students at the university.	Temporary dismissal from the university for one semester or more.
10. Any act or statement committed by the student that is harmful to religion, honour, morals, or violates the good conduct and behaviour, or which may harm the reputation of the university, committed by the student inside/ outside the university on an occasion in which the university participates or activity.	Temporary or final dismissal from the University.
11. Counterfeiting the university's documents, use of counterfeit papers for university purposes or fraud in grant procedures.	Cancellation of the certificate or withdrawal of the documents granted for him.

# B. Retake courses fees

1. Students should pay the retake course fee based on the subject fee;

2. Students should pay fees for any course he/she failed and study and do re-exam again;

3. The students who do not graduate should pay the fees determined by the university administration for re-making the course;

# O C. Refunding of the fees

- According to the university's policy, full or partial tuition fee will be refunded except application and registration fees paid by the student and it must be accompanied by evidence documents to support the request.
- 1. If the student withdraws from the registration before the start of the university study period, the tuition fees paid by him shall be refunded to him; and
- 2. If the university is unable to provide the expected education; and
- 3. If exceptional circumstances at the discretion of the university's administration take place;

# Examinations:

1) Grades of each subject shall be calculated in percentage, indicating the number of hours approved and monitoring the final grades without decimal fractions;

2) The final grades for each subject are calculated (100%);

3) Examinations of every course are divided into three. The first two assessment tests constitute 40% (20% marks each);

4) And the final exam carries 60% of the marks;

# O Multi-departments courses



In case of Multi-department courses, the department's council will designate one of the course lecturers as course co-ordinator to teach it and specify the test and assessment method in cooperation with other course lecturers;

# 📴 Final Examinations :

1) The students have the right to request the review of their grades in the final exam two weeks after the release of exam results, then the dean or his representative form a committee to investigate the non-existence of any error, and remarking the course in accordance with the administrative regulations.

2) The instructor is responsible for marking exam papers and transferring scores to the grade sheet finally and correctly.

3) The final grades in each course shall be submitted to the department head to refer to the dean of the faculty for checking and submitting it to the admissions and enrolment office.

4) The final exam papers shall be kept at the faculty deanship for one semester and then disposed of by agreement between the dean of the faculty and the admissions and enrolment office.



# Examinations Procedure:

The University's Council shall appoint an "Examinations Committee" which shall be affiliated to the admissions and enrolment office, the following are their significance

1.To inform faculty deans and institutes examination dates two weeks before the examination commencement.

2.To submit examination papers to print, prepare and save them.3.To prepare examination and invigilation schedules and preparing examination halls.4.To prepare all essential examination materials such as answer booklets, papers, tools, and others.

5.To evaluate and take appropriate action on sick and emergency conditions 6 To deliver answer papers to the lecturers to mark them. marking 7.To receive them from answer sheets after the lecturers. 8.To observe exam results prepared by the lecturers so that to review them. 9.To submit a comprehensive report on the progress of examinations to the university's council within two weeks from the date of result announcement.

# General Regulations of the examinations

1. The student is prohibited from any act or word that violates the examination rules and regulations and should be expelled from the examination hall if necessary; 2. No student is allowed to enter the exam hall after half-hour from the beginning of the examination;

3. No student is allowed to leave the exam before the end of the first half of the time allocated for the examination;

4. Each student shall sign the attendance list at the beginning of exams; 5. Papers, books or memos or any other means of communication are strictly prohibited inside the examination halls.

6. The student must show his/her ID card whenever the exam starts and whenever it is demanded.

7. No student is allowed to use any paper outside the answer booklet

# **C** The cheating in the exams:

- A. Any attempt of cheating the student will be warned if cheating attempts repeated; he/she will be treated as caught in cheating.
- B. In case of deliberate cheating, the invigilator must preserve the cheating material and record the incident in the report paper with a signature and report it to the Head of the Examination Committee.

# Cheating penalty

- A. Cancelling of the exam and considering the student failed in that course.
- B. if the student cheats for more than three courses in one semester, he/she will be subject to suspension from the university. The University's Council will handle this case.



### **R** Absence from examinations

1. Any person who misses a declared exam shall present acceptable evidence of justification to his/her Faculty Council no more than a week from the examination period.

2. Anyone absent from the final exam without acceptable excuse by the faculty council shall be considered to have zero in the exam and the grade of the class 3. Any person who misses a final exam announced with an excuse and come with acceptable justification, his/her faculty or department should request the Enrolment and Admission Office to allow the student for re-examination 4. Write the term (incomplete) to the course in which the student misses in the final exam with an acceptable excuse.

#### 장 Failure

1. Students Failed in two courses are allowed for re-exams in each semester and only once for each course.

Students who failed in more than three courses should not be accepted for re-exam.
 A student who has failed in more than half of the semester courses should repeat only the courses failed. But if a student fails less than half of the semester subjects, such

student has the right to sit in the next examination after restudying the subjects in which he/she has failed.

4. The student failed in one or two courses shall not move to the next semester, except after sitting in re-exam

Courses transferred with the student shall be restudied and examined.
 The student must pay the full semester fees partially or totally for restudying.
 If the student fails to pay for one or two courses, he/she must pay the fees for each course according to the financial regulations.

8. If the university does not provide to the student who failed more than two courses a chance to restudy, the student moves to the second semester.

#### The Grades and awards

1. The minimum pass mark for success is 60%.

2. The estimates obtained by the student in each course shall be calculated as follows:

A. Highest Academic Honours is awarded to the graduate if he/she obtains an average from 4.75 to 5.0.

B. The second-place honours award is granted to the graduate who obtains an average from 4.25 to 4.75 at graduation.

Qualifying for the first or second class honouring is classified as follows: A. The student should not fail in any course he/ she has studied at the university or another university.

B. The student must complete the graduation requirements within a maximum period between the minimum and maximum stay in the faculty.

C. The student must have studied not less than 60% of the graduation requirements.

#### Semester Average:

The total number of points obtained by the student shall be divided by the credit hours set for all the courses studied in the semester; the points scored are calculated by multiplying the credit hours in the weight of the grade obtained by the student in every subject he studied.





ternat and externat fransier system

1. Students are allowed to transfer to Mogadishu University according to the following conditions:

a) Students may transfer from a university recognized by the Ministry of Higher Education:

b) Students should spend at least 36% of the total credit hours at MU. c) The students' prior study should be in accordance with the university curricular system.

d) Students should not be expelled from their previous institutions for academic reasons.

e) Transferring students should apply in accordance with the faculty and department admission requirements.

2. The student may transfer from faculty to faculty or department to department according following within the university to the regulations: a. f there is a vacant seat in the faculty or department to which he or she wishes to transfer.

b) If the student has not previously transferred from another faculty or department. c) The academic record of the student transferred from one faculty to another within or outside the university shall include all the courses that have already been studied and related to the new specialization, including the estimate and random rates throughout his university studies

3. A committee shall be formed by the Dean of the Faculty in which the student is transferred to, as well as the departments of admissions and registration, to consider applications for transfers to the university or faculty for acceptance or rejection.

- 2. On 2005, the University started the MBA program in collaboration with the Open University of Malaysia (OUM);
- 3. On 2011 the University of eAsia (AeU) online postgraduate program was introduced with disciplines of business and computer science;
- 4. On August 2013, MU started its own postgraduate program;

# 😭 The University President

The president of the university is responsible for the administration of the university and has the following executive powers:

1. To manage the academic, administrative and financial affairs of the university to serve its mission and achieve its vision and goals;

2. To maintain command and the administrative order in the university and take the necessary measures to ensure the smooth flow of its work in a way that serves its mission and goals;

3. То sign contracts and agreements with entities and individuals: 4. To represent the university in its relations with all institutions and individuals;

# the vice president for administration and finance

The mandate of this office is to plan, organize and supervise the work of the departments and offices under its responsibility and follow up on the implementation of planned programs. It examines the reports and analyses provided by the planning department to make special recommendations to the president to issue the necessary decisions. The office is also responsible for the professional development of the administrative and financial staff and protecting their rights in compliance with the laws and the procedures of the university.

In addition to that, this office also plans, organizes and follows up the implementation of the plans of the administrative work according to the approved regulations and procedures, as well as the administrative responsibility of the university in the absence of the president. This office controls and directly supervises the following offices:

Financial Office, Human Resource Management Office, Office of Supplies and Procurement, Office of Student Affairs, Office of Quality Control and Planning, Office of the president, and the office of the Institute for Somali Studies.

#### vice president for relations <mark>8-8</mark>

This office develops and coordinates the relations of the university with the official bodies, local or regional organizations and institutions. It is also mandated to expand the university's local and international networks by seeking new international and national partners in accordance with the mission of the university.

Besides, this office also enhances the university's image and its relations at home and abroad through meaningful activities and communications. It is the job of this office to keep up with the rapid developments and achievements of the university in relation to its stakeholders.

## Vice president for academics

The Office of the Vice President for Academic Affairs oversees the academic administration of the University. That is by focusing on the smooth-running of the different activities of the Faculties and departments of the University. For this reason, the academic office is considered the backbone of the university administration. The following are some of the main functions of the Vice-President for Academic Affairs:

1. Follow up academic affairs of the University with deans, faculties, and departments;

2. Follow up academic staff affairs and enforce their performance and academic promotions to improve their practical performance supporting their participation in academic activities;

3. Ensure an appropriate teaching and learning environment at the University;

4. Hold periodic academic meetings, follow-up academic committee activities and ensure the implementation of the Academic Deans Council decision;

5. Follow-up curriculum development study plans for existing academic programs; and propose methodological and non-curricular programs and supervise their adaptation; 6. Participate in the policy meetings of the council of deans, university council, academic council and relevant committees;

# 🛅 Office of the President

This office takes the responsibility of organizing the work and administration of the president's office, arranging meetings, receiving guests, making calls, preparing letters under the president's signature, keeping original documents, maintaining the confidentiality of information available to the office and securing university reputation. The office also preserves the presidential speeches and follows up on the implementation of the president's decisions with the relevant authorities at the university.

The office is also responsible for receiving incoming messages to the president, answering questions and resolving problems. The office also prepares meetings with the president and records the minutes, as well as maintain the integrity of the documents. Received documents and reports are preserved for archiving.

# Internal audit office

The office of internal audit ensures the activities of the departments of administration and finance systems. The mandate of the (IA) office is to supervise the conformity of such departments to the University procedures and policies based on the specified objectives of the university. The office also ensures the accuracy and soundness of financial procedures before and after disbursement and supervises the preparation of final accounts and annual inventories as well as correcting staff errors and directing them according to the provisions and procedures approved.

# Quality assurance and planning office

Quality Assurance and Planning Office focuses on planning, organizing, and overseeing all university activities to ensure the effective and efficient implementation of its terms of reference. This office develops and plans quality standards at the University. The office specifically designs and plans for quality control and ensures its implementation by all University departments and offices and submits periodic reports. Moreover, the OQCP encourages the personal development of the University staff to raise capacities.

# Public Relations and Media Office

The Public Relations (PR) office is the official liaison between the University and general public, university immediate community, regional and federal governments, private sector and local non-governmental organizations/partners, In addition to its close relations with regional and international universities and higher education institutions. So, PR and Media Office is responsible for a broad range of university communications functions, including marketing, media relations, photography, production of publications, distribution of information about the university to internal and external audiences, and public service announcements.



# finance Office

The Office of Finance manages financial affairs within the policies, procedures and instructions of the University to achieve the objectives of the University and the tasks entrusted to it. The office performs its functions within the prescribed specifications, including controlling of University expenditures, avoiding loss, and preventing disruptions in the financial operations of the University by applying and organizing the general budget procedures of the University. The office ensures to carry out these functions in compliance with the set of policies and procedures of the University. In addition, the OF provides financial advice in the field of finance to senior management in financial decision-making.

The office prepares financial calculations and forecasts to the senior management and supervisors in a manner consistent with the rest of the departments and faculties and the organization of financial standards.

#### Procurement and Maintenance Office

The mandate of this office is to plan, procure, and maintain the property of the University. The PMO looks after the needs of departments, faculties, and centres for a fiscal year in terms of equipment, furniture, plumbing, carpentry, and electricity.

The main activities of this office include:

1. Supervise the PMO technicians for the maintenance and installation of the various works in the university facilities daily.

2. Follow-up the operations related to the appropriate maintenance of the University buildings;

3. Ensure the maintenance of university cars and generators, and keep data for all suppliers according to their specialization and products;

4. Conduct market surveys for materials and prices to give the administration the freedom to choose and make decisions on time;

5. Supervise and secure the supplies, tools, stationery and the implementation of the special procedures within the regulations and procedures intended;

6. Prepare contracts of purchase, operations and rent for the work of the University;

7. Participate in the annual inventory committee to take note of the buildings, equipment, laboratories within the prescribed mechanism;

8. Confirm the implementation of safety procedures at all University sites and prepare a plan for evacuation in case of fire;

## Human Resources Office

The HR office is responsible for everything related to the employees. It looks after the hiring, Firing, and retirement of the employees. The PMO recruits lecturers and other staff to fill any vacancies available and cares about employee rights and needs during the period of their work at the University. Moreover, the HR office looks after the personal and professional development of the employees by organizing seminars and workshops to enhance their knowledge and skills. This office will raise their competence and improves their performance in their

various jobs. Likewise, the office encourages innovation and creativity as a motive to retain them within their contracts.

This office comes under the responsibility of the office of the Vice President for Administration and Finance, which determines the HR policies and development programs.

#### Admission and Enrolement Office

The Admission and Enrolment Office is one of the most important offices of the University. The duties of the office are to register new students and enrol current students to continue their studies. The OAE provides direct services to the students by following up their studies, exams and progress to the different levels of their education until they graduate. In addition, the OAE provides advice about their educational progress to the students to graduate on time; and acts as a link between the students and the administration.

Admissions and Enrolment Office continuously deals with students during their studies at the University, from the beginning of their admission to the University to their registration in the faculties and departments, up until their graduation from the University.

# Center for community services and continuing education

The Mother and Child Educational Care Center was established in January 2006 to protect Somali women against gender-based violence, particularly the practice of Pharaohnic Circumcision and to improve maternal and child health care through raising the health and educational awareness of the mother.

# 🗧 Vision of the Center

To be a leading center in the fight against the practice of Pharaohnic circumcision and all forms of violence against women by improving the quality of health care and a decent life for Somali women and children

#### Objectives of the Center:

1. To eliminate all forms of violence against women and Pharaonic female circumcision in particular;

2. To establish a conducive and enabling environment for public dialogue and debates against Pharaonic circumcision;

3. To improve mother and child health care system;

4. To enable and empower women through education;

5. To mobilize and persuade communities and concerned authorities to enact laws prohibiting female genital mutilation;

# Scope of the program

The center works with internally displaced communities to stop and end the practice of Pharaohnic circumcision and promote women's health;

• The center organizes and delivers social awareness programs for university students to end the customs and social traditions related to Pharaohnic female circumcision;

• It works with the primary and secondary schools and their networks to raise awareness against Pharaonic circumcision;

• It coordinates with the efforts of women's organizations working for the same purpose; Finally, the center works with imams, prominent community figures and opinion leaders of the Somali civil society to bring positive change in the fight against Pharaonic circumcision.



# Somali Center for Water and Environment

The Somali Centre for water and environment was established to work the improvement of water and environment through research, education and public awareness about this problem.

Somalis' destruction of a natural environment has caused serious damage. The following are the most significant threats to the natural environment:

- 1. Water pollution, which led to many health problems for the Somali people;
- 2. Recurrent waves of droughts that have swept the country, affecting humans, animal wealth and natural environment;
- 3. Unlawful hunting and unfair hunting of wildlife, which threatens to extinction;
- 4. The moving sand dunes threaten the agricultural lands;

# 🎯 Objectives

The following are the objectives of the Centre:

1. Provide scientific research and studies describing the environmental degradation caused by the civil war, and assessing the extent of destruction suffered by the water and environment;

2. Develop methods and ways to protect the environment that contributes to widening the circle of social awareness to understand the environment;

3. Make every effort to reach the facts that guide us to formulate specific policies on water and environmental problems;

4. Issuing an annual publication that examines water and environmental issues;

5. Organize seminars and workshops on water and environmental issues information sharing;




